STATE ANNUAL TOURISM EXCELLENCE AWARDS (2022-23)

The World Tourism Day is celebrated all over the world on 27th September every year. The day is observed to create global awareness about the importance of tourism and its impact on society in various fields. The date has special significance as it was chosen to mark the anniversary of the day when the statutes of UNWTO (United Nations World Tourism Organization) were adopted in 1970. This is considered a major milestone in the history of Tourism. This year the theme of the Tourism day is **“TOURISM & GREEN INVESTMENTS”**

2. Andhra Pradesh Tourism Authority, Government of Andhra Pradesh is celebrating World Tourism Day on 27th September, 2023 with great interest by organizing various special events and festivities. It has been decided to present Andhra Pradesh State Tourism Awards in various categories, as indicated below in order to promote tourism in the State on the eve of World Tourism Day celebrations on 27th September, 2023.

WORLD TOURISM DAY 2023

3. Ever since its inception, World Tourism Day is celebrated on 27th September to foster awareness among the international community of the importance of tourism and its social, cultural, political and economic value. As the official day set aside in the United Nations Calendar the celebration seeks to highlight tourism's potential to contribute to reaching the Sustainable Development Goals (SDGs), addressing some of the most pressing challenges society is faced with today.

Theme for 2023: “TOURISM & GREEN INVESTMENTS”

4. UNWTO has identified investments as one of the key priorities for tourism's recovery and future growth and development. For **World Tourism Day 2023**, UNWTO highlights the need for more and better-targeted investments for people, for planet and for prosperity. Now is the time for new and innovative solutions, not just traditional investments that promote and underpin economic growth and productivity.

World Tourism Day 2023 will be a call to action to the international community, governments, multilateral financial institutions, development partners and private sector investors to unite around a new tourism investment strategy.

GUIDELINES

5. Andhra Pradesh Tourism Authority, Government of Andhra Pradesh **presents State Annual Tourism Excellence Awards** under various segments of Travel and Tourism Industry. The State Tourism Awards are presented to classified hotels, approved travel agents, tour operators, writers, education institutions, etc., in recognition of their performance in their respective fields and also to encourage healthy competition in order to promote tourism.

6. The entries for the award should have been published or the activities organized during the period from April 2022 to March 2023

- (a) Last date for receipt of entries is: **19-09-2023, 05.00 p.m**
- (b) Entries should be sent as hard copies by post and strictly in the formats where specified.
- (c) Each entry should be accompanied by a **100 word write up on the entry**, a high resolution photograph of the award winner or award winning entry of min 100 dpi for inclusion in the award brochure, if the entry wins an award. The material should be sent in digital format on USB Drive.
- (d) Each entry should be sent in a sealed packet / envelope containing the entry must have the name and contact details of the organization submitting the entry **along with the category for which the entry is being submitted.**

a) BEST HOTELS (Five awards)

5 awards are presented to the classified hotels as per the following classification.

- 5 Star Deluxe
- 5 Star
- 4 Star
- 3 Star
- Budget Hotel

The basis for State Tourism Awards for Hotels on the approved list of the Ministry of Tourism would be their earnings and tourists handled. The star category classification is based on the ambience, services, facilities & earnings duly supported by the certified copy of the Chartered Accountant. The awards will be based on the performance during the year 2022-23 (April 2022 to March 2023).

The criteria for selection would include the following:

- The basis of selection for awards in this category would be highest earnings accrued from handling tourists during the financial year 2022-23 (April 2022 to March 2023) duly supported by statutory auditor certificate of this service provider only
- A copy of acknowledgement of Income Tax Returns for the latest Assessment year (April 2023 - March 2024).
- Due weightage would be given for the growth rate achieved.
